Foundations in Health & Safety e-learning ** Required Training **

The federal Child Care & Development Block Grant (CCDBG) pre-service/orientation health & safety training requirements makes child care employees & volunteers required to complete the training by September 30, 2017.

Those child care employees & volunteers affected by this federal law are:

- caregivers in family day care & group family day care programs (providers, assistants, substitutes)
- caregivers in small day care centers (providers, assistants, & substitutes)
- directors in day care centers & school age child care programs
- teachers & assistant teachers in day care centers & school age child care programs
- substitute teachers & substitute assistant teachers in centers & school age child care programs
- volunteers in all programs, who have the potential for regular and substantial contact with children at the child care program.

There is no charge for the training, which can be found at: www.ecetp.pdp.albany.edu/elearn_catalog.shtm.

- each individual must create an Early Childhood Education and Training Program (ECETP) account with the Professional Development Program (PDP).
- Accounts can be set up in minutes and require only a little information.
- Certificates are awarded at the end of the session and must be printed and kept on file at the child care program. If a certificate is misplaced, another can be printed from the website.

OCFS Child Care Forms

Required OCFS forms are available on their website at http://ocfs.ny.gov/main/documents/docsChildCare.asp.

Please make sure you are using the most current version of the forms. When you run out of forms, print new ones directly from the website, or go to http://ocfs.ny.gov/main/documents/docs% 20Pubs.asp and you can order free copes using the order form.

If you choose to use your own form, make sure you include all the information from the corresponding OCFS form.

Glitter Slime Monsters

Materials:

- Clean baby food jars (paint the lids)
- 1 bottle Elmer's Glitter Glue
- 1 Cup Water
- 1 tsp Borax
- 1 tb Water
- (You can replace the Glitter Glue for regular white glue to make normal slime.)

Instructions:

- Mix 1 tsp. Borax and 1 Cup water together. (You can find the Borax at your local stores in the Laundry section.)

- 4. Then pour the Borax mixture into the glue mixture. Let their little hands work the magic as they combine the glue and the Borax mixture together. Right away you will see how the Glitter Slime will start to form.
- ⇒ TIP: Don't throw the extra Borax mixture yet.
- ⇒ If the slime gets too slimy you can put it back inside and it will harden some more.

DISPUTE RESOLUTION CENTER

The Dispute Resolution Center (DRC) was established in 1982 as part of the statewide network of Community Dispute Resolution Centers created through legislation enacted by the New York State legislature. All of the 62 counties in the state of New York either have a Community Dispute Resolution Center or belong to one that covers their county.

DRC's mission is to promote the peaceful resolution of conflict. DRC is a nonprofit agency that provides mediation, education, training and consultation throughout Orange, Putnam, Sullivan and Ulster Counties. DRC programs help families, youth, communities and workplaces helping to prevent and resolve conflict.

Mediation services are provided for almost any type of conflict with two or more parties including: Agricultural, Early Intervention, Manufactured Housing, Special Education, VESID, Custody/Parenting, Child Support, Civil/ Small Claims, Community, Elder, Landlord/Tenant, Neighborhood. Property, Parent and Youth, Family, Employees, Workplace, Couples (pre-nups, separation. Mediation divorce, post-divorce.)

Educational programs offered are: Parents Apart: for co-parenting strategies; MAAP: for managing anger & aggression; MAAP Jr: for kids ages 10– 17 for managing anger & aggression.

Training programs include: Basic Mediation Training; CASA Training for Court Appointed Special Assistants & Advocates (CASA); Conflict Skills Training for businesses, nonprofits, schools and organizations.

Consultation services for individuals and groups are available for mediation and customized conflict skills training.

So what exactly are family and youth mediation programs and how can they benefit my family?

As an alternative to traditional ways of resolving conflict (yelling, grounding, silent treatments) our parent/youth

mediation program brings the family unit together to talk out their conflicts and concerns in a nonjudgmental and informal environment. All participants work collectively to develop solutions and make all final decisions together. Mediation gives each participant an equal voice often reducing tension in the household. This program is ideal for parent(s) and youth ages 9 to 19. A mediator can help you talk things through to a solution.

Through mediation you can settle custody and visitation cordially and respectfully by sitting down with a neutral third party, a mediator, to figure out solutions that will work for you and the other parent and most importantly, for your children. Through mediation you can save time and money, avoid going to court and keep your children out of the middle of the conflict.

A respectful way to end a marriage without going to court: The DRC provides couples mediation for separation & divorce, pre-nuptial agreements, post-marital agreements and post-divorce issues; helping you to save time and money.

Federal law requires that school districts offer mediation as an alternative to an impartial hearing when disagreements arise. Special Education mediation is a process where parents of children with disabilities and school districts meet with a neutral mediator to work out their differences. The mediator helps participants listen to each other's views, and then assists them to develop a mutually satisfactory solution using conflict resolution skills.

Peer mediation is an excellent alternative means of dealing with students' conflicts. Students voluntarily meet with trained peer mediators to resolve conflicts and disputes in a manner that is fair and acceptable to all. Teaching characteristics of mediation, such as communication, neutrality, confidentiality and empowerment, allows students to resolve their own problems in a healthy, peaceful manner.

If you have concerns with your child's behavior, discipline, truancy, or your children are experiencing problems in school, such as, suspensions our toll free 24/7 Family Intervention line is available 1-866-567-4612 to Sullivan County parents and youth, including youth at risk of PINS. This program provides family intervention, support, mediation services and follow-up opportunities. Our staff is trained to diffuse the immediate conflict taking place between parents and youth with supportive dialogue and resources. We will help clarify concerns, explore options and make referrals when necessary.

Better together: is a series of educational sessions for both youth and their parents. Each meeting provides two trainers where one is with youth participants and another who meets exclusively with their parents. Each session has a focus on communication, managing emotions, understanding the ripple effect of all actions and a variety of other educational topics that are selected by the youth trainer based on the participants' needs. Parents have an opportunity to work with an adult trainer to help them have a better understanding of how similar all parents are in working with their children and that they are not alone. Parents learn techniques to help themselves and their children bring down the wall that currently separates them.

Court Appointed Special Advocates (CASA) of Sullivan County: CASA volunteers are "a powerful voice in a child's life" who have been abused or neglected. Appointed by Sullivan County Family Court Judges, they speak up for the child's needs in the courtroom and community. CASA volunteers will monitor court orders, and provide a report to the Family Court Judge on the progress of the family in obtaining permanency for the child.

PARENTS: Visit & Ask Questions (in person & over phone) Interested in a child care program? Make an appointment to visit! Visiting a program is the best way to judge if it will be a good fit for your child and family. We recommend visiting at least 3 programs before making a decision.

Things to keep in mind:

- Visit during regular business hours when children are present
- · Plan to stay at least an hour
- Try to bring your child to see how s/he responds to the program staff and environment

Message from Donna Willi, Executive Director

Hello Friends of Child Care!

Sullivan County's economy is fast growing and we currently have only sixty-one regulated child care programs. These programs have space to provide care for approximately 1,956 children ages six weeks to twelve years old. These programs work hard each day to provide a safe and nurturing environment so parents and caregivers can work but they cannot do it all. Currently the towns of Bethel, Cochecton, Forestburgh, Fremont and Rockland have no child care options at all. Sullivan County needs child care now and as our economy continues to grow we will need more child care; and not just any child care, high quality child care.

High quality child care has many components, including knowledge of appropriate early childhood development. To that end, the Council is offering Sullivan County's first ever Child Development Associate series. Our inaugural class anticipates completion of their CDA by late Fall 2017! In addition, the Council is now offering CPR and First Aid to our child care workforce. Check out our calendar for the schedules.

And, finally as a result of increased visits and technical assistance programs we have seen a significant decrease in citations and an increase in the quality of care offered.

Our child care work force works hard each day. We all need to keep working and looking forward in order to ensure all of our families have high quality child care options. If you, or someone you know is interested in opening their own child care program call the Council for more information.

Important Changes to Provider Compliance History

OCFS is preparing to start posting six-year compliance histories of licensed/registered child care programs, rather than the two-year histories that are currently posted. This will provide more information to parents seeking child care and will promote greater governmental transparency.

This change took effect May 17, 2017.

It is not being applied retroactively. However, two-year histories that are already posted on the OCFS website may now remain there for up to six years.

Medication Administration Training (MAT)

Only topical ointments, sunscreens and repellents are legally permitted to be applied in a child care setting without a license or registration to administer medication.

Child & Adult Care Food

Hello CACFP providers! We have a lot of new and exciting changes with the program this year. Most of these changes will be discussed at the mandatory meeting on September 13th or the 21st, whichever you attend. *All CACFP providers are mandated to attend this meeting*. Mandatory program changes will become effective as of October 1, 2017.

These changes will help maintain better nutritional guidelines for the children in your care. Remember the goal is to have children enjoy nutritious snacks and develop good eating patterns at an early age that they will hopefully maintain throughout their life. Some of the changes are as follows (and will be explained in further detail at the meeting):

- · Whole grains must be served once a day
- Infant menus offer better variety, including the allowance of approved yogurts and whole egg
- Breakfast may contain protein to replaced a grain, up to 3 times a week
- No grain based desserts including, but not limited to, cookies, granola bars & toaster pastries
- Lunch/supper must include a vegetable
- Tofu and soy yogurt are credible
- No high sugar yogurts / cereals
- Snack may contain a fruit & vegetable as two separate components
- Water needs to be available and seen at program visits, but does not need to be written on menus
- There are more infant changes that will also be discussed.

Other new CACFP changes include online claiming. All providers must enter the child enrollments via KidsKare online. Once you have entered the child enrollment, print them, have the parent/guardian sign and send them to the Council. Once they are entered online claiming will be a very easy process. All enrollments should now be entered and submitted online. Meals can be chosen by a drop down bar and menus can be submitted monthly this way. No paper, no stamps. Simply send via the web to sponsor.

Educational Incentive Program (EIP)

.8 Supervision of children

(a) Children cannot be left without competent supervision at any time. Competent supervision includes awareness of and responsibility for the ongoing activity of each child. It requires that all children be within a caregiver's range of vision except as provided in section 417.8(b) of this Part and that the caregiver be near enough to respond when redirection or intervention strategies are needed. Competent supervision must take into account the child's age, emotional, physical and cognitive development.

DCC & SACC

.8 Supervision of children

(a) Children cannot be left without competent supervision at any time. Competent supervision includes awareness of and responsibility for the ongoing activity of each child. requires that all children be within a teacher's range of vision and that the teacher be near enough to respond when redirection intervention or strategies are needed. Competent supervision must take into account the child's age emotional, physical, and cognitive development.

From the Desk of the Registrar

I would like to remind all child care providers & staff how critical supervision is everyday. The number one way to keep children safe is to be supervising appropriately; which includes predicting how the children may act or react to different situations and environments.

Although supervision may seem like something we master with experience, supervision *always* needs to be considered and evaluated with regards to the regulatory standards we are given.

Child care providers have keen senses which include that of hearing and vision and are particularly good at multitasking their senses. These heightened awareness skills are built through years of experience working with children.

We must not allow our comfort in relying on these skills to distract us from the key component of supervision which is having children in your direct sight and being near enough to intervene.

Continuing education in any field is important to educate us on new research and to remind us of the basics. Many of you have had an extraordinary amount of training and hopefully you are still learning new tips and ideas. Even if the concepts aren't new, try to use training as a self reflection/evaluation tool. Be honest with yourself on areas that you can improve and implement techniques to strengthen the weaknesses that you may have identified.

Regulations which speak to supervision are in place to protect the children and the provider and to keep the children out of physical or emotional harm. In order to provide good supervision, we must know the children's individual developmental skills and curiosity and what is expected according to their development or age.

Please review Regulations regarding supervision, found in section .8 Supervision, for all modalities.

Dear Jodi

Dear Jodi,

I have recently been cited for supervision when the children are in a different room than me for a brief period of time.

I am trying to make sure I stay in compliance but there are some issues as a family child care provider that arise because I am alone with the children. For example, if one child needs assistance in the bathroom, what is appropriate as far as indirect supervision of the other children, being that it is inappropriate to have all the children in the bathroom. Also, what am I to do when I need something such as a blanket or a box of cereal that is in the other room?

I am looing for advice on the key situations where it becomes impossible to have direct supervision of all children at all times.

Trying to supervise appropriately

Dear Trying,

Luckily, you are not the first person to have these issues arise and OCFS has directly addressed many of the issues presented to a family child care provider regarding supervision in Policy Statement 15-1, Supervision Issues as they relate to home based programs, in order to give more insight as to the intention and acceptable alternatives to direct supervision:

...If there are no other caregivers in the program, the Office recommends that the caregiver engage the children in an activity in a location close enough to the bathroom to allow the caregiver to hear the children. The children should always be told where the caregiver will be in case they need him/ her immediately.

If only one caregiver is present, he/she should never be on a different floor from the children in his/her care and should not be physically absent from the children in his/her care for more than a few minutes. This requires that children be moved to the same floor as the caregiver for the few minutes it takes for the caregiver to use the bathroom. It is critical that the space where the children are waiting for the sole caregiver to use the bathroom is safe.

I would recommend that any individual who may be caring for a group of children by themselves review Policy Statement 15-1, which can be found at http://ocfs.ny.gov/main/childcare/policies/15-1.pdf.

Legally Exempt News

NEW Mandatory/Required Health & Safety for Legally Exempt Providers

You are **ONLY** exempt if you are the child/ren's:

- Grandparent or Great-grandparent,
- · Sibling AND living in a separate residence
- Aunt/Uncle

ALL other providers MUST complete training by 9/30/17.


