### **Beyond Required Training Hours**

We all know training is an important part of working in a program with young children that is regulated by the state. Training is essential to providing a safe and comfortable learning environment for our students. It keeps us up to date with safety procedures and health and nutrition practices. It gives us guidelines for how to have a successful early childhood program and is important to keep us informed of regulations we need to observe in order to stay in compliance. However, in the early childhood world many of us talk about training and professional development as the same thing; when in fact they can be very different. In contrast to training, Professional Development has a more personal emphasis. It's about learning new information and strategies to improve your practice and to grow in your career. Actually, attending professional development not only helps improve your own skills, but can directly affect the students that you teach. Teachers who receive significant professional development can boost their students' achievement substantially! Professional development events also give you the opportunity to connect with your colleagues, to share ideas and to brainstorm solutions to the real issues you deal with each day. Sometimes it is easy to forget that we are not alone in our work, that there is a whole community of early childhood educators out there who experience the same frustrations and challenges. Taking the practical information you learn through professional development and using it at your program will not only help your children, but can actually make your job easier! Most importantly, professional development is also about building knowledge and experience so you can take the next step in your career. ### Ways to Use the Statewide Training Calendar

Our Statewide Training Calendar is a useful tool that can provide opportunities to help you grow in your practice. You can use it to find professional development by searching for trainings by topic, age group, or a specific trainer that you have liked in the past. The system will look through all titles and course descriptions to find professional development that matches what you are searching for. You can also look for training events that are happening nearby in your city, county or region. If you have a busy schedule, try searching the statewide training calendar by date and check out what's being offered in the evenings, over the weekends or other times you are free. All events on our Statewide Training Calendar have been reviewed and approved so you know you are getting high quality professional development. Did vou know that directors and administrators can use the calendar to track in-house sessions? Just submit your training information to The Aspire Registry before the session and once it has been approved, you can print out a pre-generated sign-in sheet and certificates for attendees. When your training is complete, you can upload the sign-in sheet directly to The Aspire Registry and each person will automatically receive credit on their Aspire profile. Trainers in The Aspire Registry can also set up professional development events using the Statewide Training Calendar. All events can be posted on the public search calendar, and are given Professional Development Level based on both the content of the event and the level of the trainer. ### Breast & Prostate Peer Education

The Breast and Prostate Peer Education (BPPE) Project is a new program funded by the New York State Department of Health and executed by Catskill Regional Medical Center (CRMC) and other agencies across New York State. The goal of the program is to increase screenings for breast and prostate cancer by educating Sullivan County residents about the benefits of early detection and introducing residents to programs that help them get appropriate can screenings. In the second and third years of the grant program the Sullivan County BPPE will expand its education and referral services to include the whole mid-Hudson region.

Breast cancer is one of the most common cancers among women in New York State. Each year in New York, over 15,000 women are diagnosed with breast cancer and over 2,600 women die from the disease. It is estimated that one in eight women will develop breast cancer during her life. Breast screening increases the likelihood of identifying breast cancer at an early stage when treatment is most successful. Excluding skin cancer, prostate cancer is the most common cancer among men in New York. Each year in New York State, almost 15,000 men are diagnosed with prostate cancer and about 1,700 men die of the disease. It is estimated that one in seven men will develop prostate cancer during his life. Prostate cancer occurs mainly in older men, with about two-thirds of cases diagnosed in men age 65 and older. The Sullivan County, BPPE focuses on two priority populations. The first group is women between the ages of 50 and 74 who have not been screened for breast cancer according to the current clinical guidelines or who have experienced changes in symptoms. The second priority population is men 50 years and older or those that may be at higher risk for prostate cancer due to family history, race, or ethnicity. From within those groups, CRMC is concentrating its efforts on individuals who are uninsured or underserved due to socio-economic status, geographic isolation or language barriers. An important component of the Sullivan County BPPE will be to link people who need screenings with the doctors who provide them as well as to healthcare service agencies that can help with costs, language barriers and transportation.

The BPPE Program is building relationships with community members and groups as well as healthcare providers and facilities. The Program educators are looking to network with community groups whose membership includes individuals from the target populations or that serve the target populations. ### Message from Donna Willi, Executive Director

#### Happy Spring to All Our Friends and Neighbors!

With Spring comes many special things, one of the most important is Provider Appreciation Day! Provider Appreciation Day is on Friday, May 12, 2017. A special day set aside to recognize our child care work force. Remember to say thank you to your child care program and provider!

Sullivan County currently has sixty two regulated child care programs and forty one programs exempt from regulation. These programs have space to provide care for approximately 2,200 children aged six weeks to twelve years old. These programs work hard each day to provide a safe and nurturing environment so parents and caregivers can work. Remember to thank your provider on May 12<sup>th</sup> and every day.

Now think about this, according to the US Census, Sullivan County has approximately 4,500 children aged six weeks to twelve years, leaving 2,300 children without a formal child care option with infant care being in highest demand. Here at the Council we not only work hard to provide support and services but we also work hard to find solutions to the challenges that our families face. On December 2, 2016 the Child Care Council was notified that we are one of 237 award recipients of the New York State Nonprofit Infrastructure Capital Investment Program or NICIP. This grant will allow us to provide much needed energy efficient and safety upgrades to our office space. These upgrades will not only provide our staff and the families that we serve a safer service environment but it will also provide for a high quality learning & infant/toddler child care center with a capacity to serve up to four infants and toddlers. The anticipated opening of the center is expected to be early Spring, 2018.

And new in 2017, the Council began offering the first ever **C**hild **D**evelopment **A**ssociate series. Our first group of providers anticipates completion of their CDA by late Fall 2017!

And, finally as a result of increased visits and technical assistance programs we have seen a significant decrease in citations in our child care programs.

Our child care work force works hard each day but we all need to keep working and looking forward in order to ensure our families have high quality child care options.

PARENTS: Visit & Ask Questions (*in person & over phone*) Like the sound of a program? Make an appointment to visit! Visiting a program is the best way to judge if it will be a good fit for your child and family. We recommend visiting at least 3 programs before making a decision.

### Things to keep in mind:

- Visit during regular business hours when children are present
- Plan to stay at least an hour
- Try to bring your child to see how s/he responds to the program staff and environment
- Bring notes or a checklist to remind yourself of questions you want to ask and things you want to observe. QUALITYstarsNY has put together a checklist to help you determine whether the program is high quality. (http://qualitystarsny.org/families-checklists.php)

# 417.7 Program Requirements pgs (16-17)

(u) If television or other electronic visual media is used, it must be part of a planned developmentally appropriate program with an educational, social, physical or other learning objective that includes identified goals and objectives. Television and other electronic visual media must not be used solely to occupy time.

(v) Television and other electronic visual media must be turned off when not part of a planned developmentally appropriate program activity.

(w) Children must not watch television or other electronic visual media during meals.

(x) Television and other electronic visual media must be turned off while children are sleeping, and during established nap times. This is not to prohibit a program from using electronic visual media for business purposes during sleep or nap time if its use does not interfere with the supervision of children.

- 418-1.7 Program Requirements (pgs 22-23) (r) The resting/napping places must:
  - (1) be located in approved day care space;
  - (2) be located in safe areas of the program;
  - (3) be located in a draft-free area;
  - (4) be where children will not be stepped on;
  - (5) be in a location where safe egress is not blocked;
  - (6) allow a person to move freely and safely within the napping area in order to check on or meet the needs of children; and
  - (7) be at least two feet apart from each other.

(s) Individual clean bed coverings must be available, as needed, for each child requiring a rest period.

(t) Bedding, which is the removable and washable portion of the sleeping environment, must not be shared between children.

(u) Sleeping surfaces, including bedding, which is the removable and washable portion of the sleeping environment, must not come in contact with the sleeping surfaces of another **child's rest equipment during storage. Mats and** cots must be stored so that the sleeping surfaces do not touch when stacked.

(w) Children unable to sleep during nap time shall not be confined to a sleeping surface (cot, crib, etc) but instead must be offered a supervised place for quiet play.

As child care providers you are required to have continuing education. Consider how you prefer training. Do you want to hold a certificate or earn a degree? You can chose from a variety of training genres such as online, face-to-face, conferences and college credits. EIP can help to offset the cost of any approved training/education.

Consider this: If you are a child care provider for 6 years and take 3 college courses per year (about 9 credits), you can earn your associates degree using EIP scholarship money! SUNY New Paltz offers online Elementary Education courses. SUNY Sullivan offers Childhood Education Transfer Degree.

You can also use EIP to earn your CDA. The Council is now offering CDA courses. You can earn your CDA in one year.

Perhaps you enjoy social learning events, such as conferences. There are conferences available within reasonable travel distance that are EIP eligible.

Don't get stuck in the same routine. Broaden your horizons and make educational gains to benefit your future. There no better time to start than right now!

# NY Works for Children/ASPIRE

The Aspire Registry is an online system that supports early childhood professionals and recognizes the important work that you do. With an Aspire profile, you can take advantage of help-ful resources to guide your career choices and plan your professional growth.

### HOW TO COMPLETE YOUR ORGANIZATION ACCOUNT

This page should be used by directors and administrators to complete their Organization account. Instructions for how to set-up an Aspire profile are on the following page.

- Activate your Organization account Go to www.nyworksforchildren.org and click Join or Log into Aspire. Select Create an Organization Account and enter your contact information and program license number or permit number. You will receive your Organization ID and password from The Aspire Registry within 3 business days.

Copy and distribute the following page as a resource, along with your Organization ID.
- 3. Provide additional information about your program After each member of your faculty has created an Aspire profile, **use the Employees Tab to verify each employee** by selecting Update next to each name. Under the Classrooms Tab add classrooms to your account by selecting Add Group. Select the teaching staff that works in each classroom and update classroom information.
- 4. Keep your account up to date! We recommend logging into your Organization account regularly to make sure your information is still accurate. Support your staff to send in any new training or education information throughout the year.

# Legally Exempt News

All Legally Exempt providers are subject to announced or unannounced inspection and/or verification of child care to verify compliance with applicable laws and regulations and any additional requirements imposed on such a provider by the social services district.

All Legally Exempt providers are required to maintain current and accurate attendance records for each child showing the date of attendance with the time of arrival and departure; on a daily basis (full day absences must also be noted).

An eligible provider must certify that all documentation and information provided to a social services district is accurate and true. Any false or fraudulent claims for payment by a provider may result in the deferral or disallowance of payment for such claims with a social services district, and/or referral for investigation.

It is important to become familiar with the NYS Regulations & CACFP Policies and Procedures.

### Children's electric scooters
