Foundations of Health & Safety e-learning ** Required Training for all child care employees & volunteers **

The federal Child Care & Development Block Grant (CCDBG) pre-service/orientation health & safety training requirements makes child care employees & volunteers required to complete a health & safety training by September 30, 2017.

Those child care employees & volunteers affected by this federal law are:

- caregivers in family day care & group family day care programs (providers, assistants, substitutes)
- caregivers in small day care centers (providers, assistants, & substitutes)
- · directors in day care centers & school age child care programs
- teachers & assistant teachers in day care centers & school age child care programs
- substitute teachers & substitute assistant teachers in centers & school age child care programs
- · volunteers in all programs, who have the potential for regular and substantial contact with children at the child care program

To implement this new federal requirement, OCFS developed an e-learning session: Foundations in Health and Safety e-learning, that satisfies all required health and safety topics. There is no charge for the training, which can be found at: www.ecetp.pdp.albany.edu/elearn catalog.shtm.

To start the training and receive the certificate of completion, each individual must create an Early Childhood Education and Training Program (ECETP) account with the Professional Development Program (PDP). Accounts can be set up in minutes and require only a little information. The account can be set up at: https:// www.ecetp.pdp.albany.edu/mytraininglogin.aspx. All individuals who complete the Foundations in Health & Safety e-learning session will be credited with a certificate of completion. Certificates are awarded at the end of the session and must be printed and kept on file at the child care program. If a certificate is misplaced, another can be printed from the website.

Child Care Centers and School Age Child Care Group Training:

Directors of day care centers (DCC) or school age child care (SACC) programs may hold group training sessions for their staff using the Foundations in Health & Safety e-learning. Each participant in the group session must set up an ECETP account with PDP so that credit for the training can be added to the individual's ECETP account. DCC and SACC directors choosing the group method of training may not charge their employees a fee for the training nor may they train staff who are not employees of their program. The DCC and SACC director must facilitate the Foundations in Health & Safety e-learning group sessions and ask for staff participation during the interactive exercises that are included in the training. Signed rosters of those trained by the DCC or SACC director must be kept on file at the program for review by OCFS representatives. In addition, the DCC and SACC director must send a copy of the signed training roster and the Participant's Reaction Questionnaires (PRQ) to PDP after completion of the training modules. Upon receipt of these forms, PDP will enter all individual's training credit into their ECETP account. Featured Agency: PRASAD Children's Dental Health Program



In the United States, tooth decay is the most common chronic childhood disease. It affects one in four elementary school children and two out of three adolescents. Nationally, children lose 51 million school hours each year because of dental problems. A study showed that 53% of Sullivan County third graders had untreated cavities, more than double the NY State average of 24%.

According to a 2012 study published by the American Dental Association, there were 2.1 million emergency room dental visits annually. Many of these "emergencies" could have been prevented with regular dental visits. The cost effectiveness of prevention is immense.

Since the program's inception in 1998, PRASAD CDHP's mobile dental clinic conveniently visits county schools and is able to provide dental health education and preventive and restorative dental services without parents needing to take time off from

work or to find transportation. The program is a clear benefit in a county where there is no public transportation and many low income children.

When children grow up with a lack of attention to dental health, they will likely continue this way into adulthood. Within many families living in poverty, poor and missing teeth often become a cultural norm, perpetuating the cycle into future generations.

PRASAD CDHP has provided dental health education or dental treatment to more than 76,000 children over the years.

Most of the children visit the mobile dental clinic on their own during school hours, a testament to the degree to which parents trust PRASAD CDHP, and the confidence the children feel receiving dental care.

A nurse at a Sullivan County school spoke excitedly of the great experience she and her students had enjoyed. "The kids loved every moment of it!" she said. "The PRASAD staff was very caring and great with the kids. This was something very positive that I'll never forget."

PRASAD CDHP has received many awards. In January, PRASAD CDHP became the sole entity to have received the New York State Dental Foundation "Give Kids A Smile Award" four times. The award was given in recognition of PRASAD CDHP's excellence in providing oral health care for children in New York State.

PRASAD CDHP's dental services include cleanings, fillings, x-rays, extractions, sealants, cavity prevention, fluoride treatment and restorative dental care treatment. Children ages six months through 18 years of age are eligible. PRASAD CDHP accepts most insurance plans including Medicaid. An appointment is required to receive any type of dental care. 

Message from Donna Willi, Executive Director

Hello Friends of Child Care!

Sullivan County's economy is fast growing and we currently have only sixty regulated child care programs. These programs have space to provide care for approximately 1,950 children aged six weeks to twelve years old. These programs work hard each day to provide a safe and nurturing environment so parents and caregivers can work but they cannot do it all. Currently the towns of Bethel, Cochecton, Forestburgh and Fremont have no child care options at all. Sullivan County needs child care now and as our economy continues to grow we will need more child care; and not just any child care, high quality child care.

According to the US Census, Sullivan County has approximately 4,500 children aged six weeks to twelve years, leaving 2,550 children without a formal child care option with infant care being in highest demand. Here at the Council we not only work hard to provide support and services but we also work hard to find solutions to the challenges that our families face.

The Child Care Council is one of 237 award recipients of the New York State Nonprofit Infrastructure Capital Investment Program or NICIP. This grant will allow us to provide much needed energy efficient and safety upgrades to our office space. These upgrades will not only provide our staff and the families that we serve a safer service environment but it will also provide for a high quality learning & infant/toddler child care center with a capacity to care for up to four infants and toddlers. The anticipated opening of the center is Spring 2018.

Additionally, the Council began offering Sullivan County's first ever Child Development Associate series. Our inaugural class anticipates completion of their CDA by late Fall 2017! The Council will also be offering CPR and First Aid to our child care workforce by the end of June 2017. Training and professional development are one component of high quality child care.

And, finally as a result of increased visits and technical assistance programs we have seen a significant decrease in citations and an increase in the quality of care offered.

Our child care work force works hard each day; we all need to keep working and looking forward in order to ensure all of our families have high quality child care options. If you, or someone you know is interested in opening their own child care program call the Council for more information.

Welcome Summer

Summer is a great time to get outside and enjoy the warm fresh air.

Meals can be brought outside to a table or you can create a picnic area to serve CACFP approved meals/snacks. Have children wash hands and help you carry out foods/utensils needed to have an outside meal or picnic.

Easy snack and meal ideas can be prepped prior to going out-doors:

- Pre-cut sandwiches and
- Fresh fruit
- Pack a cooler with cold milk and water.
- Make fresh ice pops (use dixie cups with a popsicle stick in the freezer) with 100 % juice and serve them at an outdoor snack time with another credible component.

Provide a shady area for the children to enjoy their meals. Talk about the animals or insects you see and how and what you think they eat. Talk about how the fruit or vegetables you serve grow. Do they grow on a tree? A bush? Above the ground or under ground? Grow a garden, have children help you grow and eat the foods you plant.

Encourage families to barbeque and spend some family time outdoors away from family chores and in the sunshine. Invite families over for a child care family barbeque to strengthen relationship between child care providers, children and their home life.

Enjoy summer, get outside, eat well and exercise daily!

PARENTS: **Visit & Ask Questions** (*in person & over phone*) Like the sound of a program? Make an appointment to visit! Visiting a program is the best way to judge if it will be a good fit for your child and family. We recommend visiting at least 3 programs before making a decision.

Things to keep in mind:

- Visit during regular business hours when children are present
- Plan to stay at least an hour
- Try to bring your child to see how s/he responds to the program staff and environment

Focus on the Regulations

Review Regulations @ ocfs.ny.gov

- 414.14(n) Every director, teacher, and volunteer with the potential for regular and substantial contact with children in care must complete Office-approved training that complies with the federal minimum health and safety pre-service or three-month orientation period training requirements
 - (1) Every person in the position of director, teacher, or volunteer with the potential for regular and substantial contact with children at the time this regulation becomes effective must complete the Officeapproved training by September 30, 2017. Any teacher or director who does not complete this training by September 30, 2017 must not be left unsupervised with children in care until such time as the training has been completed. The person supervising the individual must have completed the Office-approved training that complies with the federal minimum health and safety pre-service training requirements.
 - (2) Every applicant for the position of director, teacher, or volunteer with the potential for regular and substantial contact with children after this regulation becomes effective must complete the Officeapproved training pre-service or within three months of starting such position, or by September 30, 2017, whichever is later. Any director or teacher who has not completed the training, but will be completing the training within the first three months of starting such position, must not be left unsupervised with children in care until such time as the training has been completed. The person supervising the individual must have completed the Office-approved training that complies with the federal minimum health and safety pre-service training requirements.

- 417.14(q) Every assistant, substitute, and volunteer with the potential for regular and substantial contact with children in care must complete Office approved training that complies with the federal minimum health and safety pre-service or three-month orientation period training requirements.
 - (1) Every person in the position of assistant, substitute, or volunteer with the potential for regular and substantial contact with children at the time this regulation becomes effective must complete the Office-approved training by September 30, 2017. Any assistant or substitute who does not complete this training by September 30, 2017 must not be left unsupervised with children in care until such time as the training has been completed. The person supervising the individual must have completed the Office-approved training that complies with the federal minimum health and safety pre-service training requirements.
 - (2) Every applicant for the position of assistant, substitute, or volunteer with the potential for regular and substantial contact with children after regulation becomes this effective must complete the Office-approved training preservice or within three months of starting such position, or by September 30, 2017, whichever is later. Any assistant or substitute who has not completed the training, but will be completing the training within the first three months of starting such position, must not be left unsupervised with children in care until such time as the training has been completed. The person supervising the individual must have completed the Office-approved training that complies with the federal minimum health and safety pre-service training requirements.

As a director of a school age child care program I am wondering if we can take the training on line together and have it credited for everyone, or if all staff must create individual accounts and take the training separately?

NY Works for Children/ASPIRE

It's the moment you have all been waiting for... As of this week, you are now able to upload documents directly to your Aspire profile! No more photocopies, and no more mail. Now, when you are ready to update your profile, just enter your new information, upload your documents directly to the system and click submit. It's that easy!

PREFER TO MAIL IN YOUR DOCUMENTS? Although we are very excited to release document upload, we also understand that some of our members may prefer to continue mailing in their documents, and that is okay too! However, please be aware that we have slightly modified the process in which we receive documents. If you choose to mail your materials you will now need to:

- Log into your Aspire Profile first: Before you put your documents in the mail, log into your Aspire profile and add whatever new information you are submitting to the appropriate tab. Click through to the last tab and press 'Submit'. This helps to let us know what to expect in the mail.
- Include your Documentation Coversheet: When you add new information to your profile, we will email you with a Documentation Coversheet with a list of documents you need to submit. All you need to do is print out your Documentation Coversheet and mail it in along with your documents. Please note: We will no longer be accepting mailed documents without a Documentation Coversheet.

NEW RENEWAL POLICY Additionally, we are modifying our renewal process. Combi Shuttle Travel System (stroller and car seat combos)

Hazard: The car seat can disengage from the stroller's frame, posing a fall hazard to infants.

Description: This recall involves Combi Shuttle model strollers and car seats, which when used together are called a travel system.
