4th of July Twig Ornaments

Looking for a fun and easy patriotic craft for your kids to make?

These simple patriotic twig ornaments look great standing on their own or strung together in a garland and they're really fun to make!

You'll need:

- twigs (5 per star)
- red, white & blue acrylic paint
- white glue and glitter
- glue gun
- snippers
- fishing line

Preparing your twigs:

First you need to find a bunch of twigs (we went with sticks that were about the same diameter as a pencil).

This can be a fun way for little ones to get involved in the project. What kid doesn't love collecting sticks?

With your snippers, cut your twigs so they're all roughly the same length. You can vary the size of your stars; just make sure that all of the twigs belonging to one star are the same length.

Remove any loose bits of bark. This is fun, and a great fine motor activity for young children.

Paint your stars. We went with one star each in red, white and blue.

Gluing the stars:

You'll want to play with your twigs a little, laying them out to form your stars. When you're arranging your twigs to form a star, make sure all of the intersecting points touch. You'll be gluing at these points.

They'd look sweet hanging vertically from your deck or patio or even from a branch in a tree.

Featured Agency: LIONS Clubs Submitted by: Ilene Wizwer, District Governor 2017-2018



Lions Clubs International is the largest service organization in the world. It began as a commitment Melvin Jones, a Chicago bv businessman who believed that local business leaders should look bevond their own business enterprises and help the betterment of the communities and the world. What is interesting about the "birth" of the organization is that it began in 1917, one year before the end of WWI. Even 100 years ago, people were thinking globally. We now have over 46,000 clubs which can be found in over 200 countries and geographic areas. Our motto is "We Serve", and our mission is: To empower volunteers to serve their communities, meet humanitarian needs. encourage peace and promote international understanding through Lions clubs.

When people think about the Lions, the first thing that comes to mind is the collection of eyeglasses. Yes, we still do that, but as the needs of the people change, so has Lions. As of 2017, at the beginning of our second century of service, we have 5 areas of service: vision, feeding the hungry, the environment, diabetes and childhood cancer. There are 10 Lions clubs in Sullivan Each club serves its County. community with its own identifying projects. If you would like more information about these clubs, you can find the name and address of the District Governor for Lions at the end of the article.

Lions and Vision will be the main topic for this newsletter. It began in 1925 when Helen Keller challenged the Lions Clubs International at the annual convention in Cedar Point, Ohio to "become knights of the blind in the crusade against darkness." It is because of this speech that Lions worldwide have become leaders to help the blind and visually impaired. With the inception of Lions KidSight USA in 2014, the goal was to protect the sight of our children. According to education experts 80% of learning is visual. We know that learning takes place at home, almost from birth, before children officially enrolled are in an academic venue. By the time young children are experiencing certain vision problems in school it may be too late to correct them. Early detection can lead to early treatment. Our aim is to screen all eligible children from 6 months of age to 18 years old. We have been screening children in Head Start, Nana's House, and Project Excel in Sullivan County for many years. When we go into the elementary schools we do not repeat any type of eye "test" that the school nurse is doing. Lions now are involved with SEE screening. SEE is Screening Eyes Early. The volunteer Lions are trained to do the vision screenings. The parent or guardian is asked to fill out a consent form in order to have the screening done. The results of the screening are either a pass or referral.

On the consent form the referral information is attached so that the eye care professional can understand the result of the screening. With a referral it is highly recommended that the parent or guardian take the child to an eye care professional as soon as possible for a complete examination. Most important to understand is that the Lions who are doing the screening are not diagnosing any disorder. What we do is use a PlusOptiX screener that will identify 6 ocular problems: anisometropia (refraction of both eyes), astigmatism (corneal curvature which can results in blurred vision), myopia (nearsightedness), hyperopia (farsightedness), anisocoria (difference in pupil size of both eyes), and corneal reflexes (symmetric eve alignment which will show a turning of the eye known as strabismus). If a referral is noted, there is also a list of eye care professionals in a 6 county area and Pennsylvania available for distribution so the family has a choice of who to take their child/children to for further medical treatment. This year through the Sullivan County Lions Sight and Hearing Committee we will have screened over 1500 children. There are many more eligible children that are able to be screened. We would like to make sure that every eligible child is screened yearly to ensure that his/her vision is not compromised in any way.

Important Changes to Provider Compliance History

OCFS is preparing to start posting six-year compliance histories of licensed/registered child care programs, rather than the two-year histories that are currently posted. This will provide more information to parents seeking child care and will promote greater governmental transparency. *This change took effect May 17, 2017.*

It is not being applied retroactively. However, two-year histories that are already posted on the OCFS website may now remain there for up to six years.

PARENTS: Visit & Ask Questions (in person & over phone)

Interested in a child care program? Make an appointment to visit! Visiting a program is the best way to judge if it will be a good fit for your child and family. We recommend visiting at least 3 programs before making a decision.

Things to keep in mind:

- Visit during regular business hours when children are present
- · Plan to stay at least an hour
- Try to bring your child to see how s/he responds to the program staff and environment
- Bring notes or a checklist to remind yourself of questions you want to ask and things you want to observe. QUALITYstarsNY has put together a checklist to help you determine whether the program is high quality.

These programs have space to provide care for approximately 947 children aged six weeks to twelve years old. These programs work hard each day to provide a safe and nurturing environment so parents and caregivers can work but they cannot do it all. High quality child care has many components, including knowledge of appropriate early childhood development. To meet this need, the Council is offering Child Development Associate training series. Our Spring session will graduate our second group of Child Development Associate Candidates in June and we plan to schedule our third class of candidates for September 2018.  - Be sure to have menus in once the new month starts to receive the quickest payment.
- \Rightarrow You can use your Minute Menus Reports button to check on claims and to check to see if you had any disallowances.
 - You can use the reports tab to retrieve your monthly menu and attendance and tax forms.
- \Rightarrow Take notice of children's enrollments that are about to expire.
 - Look over each child's enrollment. Make necessary changes, then print and send signed updated enrollments for approval,—*prior to their expiration date.*

- (b) Rooms that will be used by the children must be well-lighted and well-ventilated. Heating, ventilating and lighting equipment must be adequate for the protection of the health of the children.
- (d) A temperature of at least 68° degrees Fahrenheit must be maintained in all rooms to be occupied by children.
- (n) Adequate and safe water supply and sewage facilities must be provided and must comply with State and local laws. Hot and cold running water must be available and accessible at all times.
- (a) Suitable precautions must be taken to eliminate all conditions which may contribute to or create a fire hazard.

.4 Fire Protection

(a) Suitable precautions must be taken to eliminate all conditions which may contribute to or create a fire hazard.

.5 Safety

- (a) Suitable precautions must be taken to eliminate all conditions in areas accessible to children which pose a safety or health hazard.
- .5(b)(7) Each program must have on site a variety of supplies \rightarrow

including food, water, first aid and other safety equipment to allow for the protection of the health and safety of children in the event parents are unable to pick up children due to a local disaster. The plan must take into account a child's needs for an overnight stay. Food supplies must be non-perishable and of sufficient quantity for all children for an overnight stay.

- (m) Communication.
- A working telephone must be available for use by all caregivers at all times children are in care.
- (r) An operable flashlight or battery powered lantern must be kept in the child care area. Such equipment must be properly maintained for use in the event of a power failure.

.11 Health & Infection Control

- (1) Caregivers and volunteers must thoroughly wash their hands with soap and running water...
- (2) Caregivers and volunteers must ensure that children thoroughly wash their hands or assist children with thoroughly washing their hands with soap and running water ...

We try our best to plan for emergencies to the best of our abilities. Planning for emergencies will help ease the stress of the unknown outcomes of storms and high winds or other unforeseeable events.

As long as you can remain in compliance with the regulations, you may remain open for business.

A few regulations to keep in mind are found under Building & Equipment, Safety, and Health & Infection control, for example:

- \Rightarrow Room used by children must be well lit and ventilated.
- ⇒ Minimum temperature of 68 degrees must be maintained.
- ⇒ Adequate and safe water supply & sewage facilities must be provided. Hot and cold water must be available & accessible at all times.
- ⇒ Suitable precautions must be taken to eliminate all conditions which pose a safety or health hazard.
- \Rightarrow Caregivers & children must thoroughly wash hands.

You may be able to make some adjustments to remain in compliance and open for business!

Submit your timesheets online with the Child Care Time & Attendance (CCTA) System!

We encourage all providers to submit timesheets through the web-based system, CCTA.

There are several **benefits to using CCTA** web-based provider portal such as:

- \Rightarrow Eliminate the cost of shipping, mailing and purchasing paper products and postal supplies.
- \Rightarrow Eliminate time delay of using the postal service.
- \Rightarrow TRACK PAYMENTS ON A DAILY BASIS.

It is recommended to use Internet Explorer on desktops or laptops. Most iPads and other hand held tablets are not supported by this system

REMINDER – ALL timesheets have a 60 expiration date from the last date of service. ANY TIMESHEETS that are RECEIVED AFTER the 60 expiration date (electronically or paper) will be RETURNED to provider as NOT PAYABLE
