# **Military Fee Assistance Program**

Governor Kathy Hochul announced that more than 48,000 New York State military families will now be able to receive child care fee assistance that covers 15,000 state-licensed child care providers. The military fee assistance will offset the cost of child care not covered by the parent fee as calculated by their total family income up to a maximum child care rate of \$1800 per month per child. New York State has been selected as the first state approved to qualify licensed/registered child care providers for participation in this federal military fee assistance program. Childcare providers licensed by the New York State Office of Children and Family Services will be eligible to participate and receive fee assistance on behalf of a military family under the Military Child Care in Your Neighborhood-PLUS program offered by the U.S. Department of Defense.

# **Featured Agency:** Sullivan County Rotary Clubs; Liberty, Monticello and **Livingston Manor**

Sullivan County is home to three Rotary Clubs that are part of Rotary International. Rotary International is comprised of 1.4 million members worldwide that belong to about 46,000 clubs. All of these clubs are dedicated to taking action to make the world a better place.

In our area, we have clubs based in Liberty, Livingston Manor and Monticello. The members of these clubs have a mission to provide "service above self" in order to bring about positive change in our communities, our country and the world. Each club meets weekly to develop fundraising initiatives, plan club projects and establish a warm and welcoming environment that builds good will and better friendships. Their collective efforts have incredible impact in our region and around the globe that focuses on helping those in need, support of our youth, promote local and global health, and generally improve the lives of as many people as possible.

Liberty Rotary Club has been doing good for over 70 years and works tirelessly on a variety of programs. One of their signature events is the Dave Thomson Spirit Beer and Wine Tasting, which happens annually and raises funds for local scholarships and also supports "A Single Bite". Additionally, the club is strongly committed to supporting the fight against Alzheimer's Disease, for which service this coming May. One of their Liberty Rotarians participate in two major fundraisers of a winter plunge and an annual Walk. Beyond that, the club has been working on a long-term program in Haiti that has provided water filtration systems to 1,000 families to assure they have clean, potable water. The Liberty Club also hosts a Dance to Benefit Special Olympics, which is a social gathering of all neighbors including club members, community guests and a great number of residents with developmental disabilities. All this and

a plethora of other initiatives keeps the Liberty Club busy year-round making a difference in people's lives.

The Livingston Manor Rotary Club was chartered in 1954 and they have a long-term commitment to serving their community and the world, with heavy emphasis on youth. This mighty organization funds a program which provides dictionaries to the 2 nd, 3 rd & 5 th grade classes at Livingston Manor Central Schools. They also sponsor little league and soccer at their park. Additionally, they hold an annual Ice carnival in January or February with skating for all ages, exhibitions, horse drawn sleigh rides, hot dogs and cocoa. This annual event, steeped in tradition, features a dance at LMCS School with the crowning a King & Queen. This festive event encourages students to foster fellowship by inviting students from other schools to attend. All of this winter fun is absolutely free to attendees. They also hold a Drug Awareness Night at their Rotary Park for their community. Additional events include an Easter egg hunt, tree / menorah lighting, and photos with Santa. Lastly, they have an annual Head, Hands & Toes drive that consist of new hats, headbands, socks, gloves & mittens free for all. Their club also boasts a long list of other projects.

The Monticello Rotary Club will celebrate 100 years of exceptional major projects is their annual food drive. Each year on the Saturday before Thanksgiving (11/18/23 this year), their group collects nonperishable foods along with turkeys, hams, and even pet foods for distribution to The United Way of Sullivan County and The Sullivan County Federation for the Homeless. For 45 years, Monticello Rotary has run its Monster Classic 5/10k Walk/Run. This event benefits club initiatives and The Sullivan County Veterans Coalition.

Additionally, the Monticello Rotary Club collects items for those in our area nursing and rehab centers in the county, which includes lap blankets, gripper socks, comb and brush sets, puzzle/game books, scarves, hats, and fingerless gloves and distribute it throughout Sullivan County. The smiles on the faces of the patients is a beautiful thing. Beyond that, Monticello Rotary hosts the Annual Bob Rosen Memorial Golf Tournament, which raises money for scholarships. Finally, if it's a great meal for a great cause you are after, consider the Monticello Rotary Annual Chicken BBQ, which benefits DeHoyas Memorial Park. Monticello also has a host of other projects and initiatives that improve the human condition.

All three clubs mentioned above are affecting countless lives in a positive way. Each club sends students to RYLA annually, which is a program designed to build leadership skills amongst our youth. They also work collaboratively to host numerous blood drives and they fundraise for our area's W.S.U.L. Heart-A-Thon. Additionally, they support Rotary International's efforts to eradicate polio worldwide. Each club provides their local students with scholarships to assure our youth have a step up on their futures. All three clubs have impressive coat drives that provide much needed warmth to community members. They also work to feed the poor, provide basic necessities to those in need and lend support whenever our neighbors are suffering. # Child and Adult Care Food Program (CACFP) News

Winter weather is coming and it's time to start planning some indoor activities. Making sure children get their energy out is very important but can be challenging especially in small indoor spaces. Make sure to add music and movement throughout the day. Even a simple "hop like a bunny to the bathroom" or let the children have a marching band can help get the wiggles out. If you have the space I suggest bring in an outside slide or create a track with masking tape to play with trucks! Be creative and keep them active. Take them outside as weather permits and be sure parents are sending in winter accessories.

Other fun ideas are to let the children create snacks. Use learning tools while creating snacks . For example, talk about how many pretzels, what color, shapes, counting, texture and ounces there are in front of them. Let children pour and measure beverages. Talk about what they eat at home and what are their favorite snacks.

Create winter themed snacks like a snowman. Use bagels with cream cheese for the body, carrot nose, raisin buttons /mouth and pretzels as arms or brooms. You can also use crackers, tortillas cut up and then roll up meat.

Talk to the children about what makes a snack more nutritious and what snacks should be a sometimes choice. Talk to the kids through meals . This is a great time to learn manners and have conversation. Creating healthy snacks can also help master some fine motor skills.

A good snack time is engaging, learning and eating nutritiously. Make meal times expand as part of your curriculum. Add it to themes, like the color red and eat something red, or counting in two's and placing food in groups of

#### **Health and Safety Training**

Is a 15-hour Health & Safety training course intended for both brand-new and seasoned home-based providers and the directors/staff of SACC and DCC programs. The training set a solid foundation in the regulations and provide guidance in best practice with a heavy focus on keeping children safe and healthy.

# Sullivan County Child Care Council is currently offering trainings for <u>FREE</u> to all Sullivan County licensed, registered & legally exempt enrolled providers.

CPR/FA requires a deposit of \$65 to hold your spot, but will be returned upon completion of the course as long as you are an active licensed, registered or legally exempt enrolled provider.

Health & Safety Training requires a deposit of \$175 for group family and family and \$225 for all others. Your deposit will be returned upon receipt of your license, registration, or legally exempt enrollment if you are open with 60 days.

#### **Educational Incentive Program (EIP)**

EIP is sponsored by the NYSOCFS, funded by the federal Child Care & Development Fund and administered by the Professional Development Program (PDP), Rockefeller College, University at Albany.

The following grants & scholarships are available to child care providers:

- College Credit, Non-Credit Bearing & Credential Training: to assist child care providers in paying for professional development training & education
- Cardiopulmonary Resuscitation (CPR) & First Aid (FA): to assist income eligible providers offset the cost
- The MAT Rebate Program: For child care facilities to offset the cost of the training to certify staff to administer medication in a child care setting.

# Focus on the 390a Review Regulations @ ocfs.ny.gov

#### SPOTLIGHT: TRAINING

Section 390a

- 3.(a) The office of children and family services shall promulgate regulations requiring operators, program directors, employees and assistants of family day care homes, group family day care homes, school-age childcare programs and child day care centers to receive pre-service and annual training, as applicable. Provided however that such providers shall be required to receive thirty hours of training every two years; provided, however, any individual or provider who is already in compliance with this subdivision, prior to the effective date of the chapter of the laws of two thousand nineteen that amended this subdivision, shall only be required to complete any additional federal training requirements which they have not already completed in order to be deemed in compliance with this subdivision. Fifteen hours of such training must be received within the first six months of the initial licensure, registration, or employment. Such training requirements shall also apply to any volunteer in such day care homes, programs or centers who has the potential for regular and substantial contact with children. The thirty hours of training required during the first biennial cycle after initial licensure or registration shall include training received while an application for licensure or registration pursuant to section three hundred ninety of this title is pending. The office of children and family services may provide this training through purchase of services.
- (b) The training required in paragraph (a) of this subdivision shall address topics and subject matters required by federal law and the following topics or subject matters, unless such topics or subject matters are substantially covered in training that is required pursuant to federal law:
- (i) principles of childhood development, focusing on the developmental stages of the age groups for which the program provides care; (ii) nutrition and health needs of infants and children; (iii) child day care program development; (iv) safety and security procedures; (v) business record maintenance and management; (vi) child abuse and maltreatment identification and prevention; (vii) statutes and regulations pertaining to child day care; (viii) statutes and regulations pertaining to child abuse and maltreatment; (ix) for operators, program directors, employees and assistants of family day care homes, group family day care homes and child day care centers, education and information on the identification, diagnosis and prevention of shaken baby syndrome; and (x) adverse childhood experiences (ACEs), focused on

understanding trauma and on nurturing resiliency.

- (c) For the thirty hours of biennial training required after the initial period of licensure or registration, each provider who can demonstrate basic competency shall determine in which of the specified topics he or she needs further study, based on the provider's experience and the needs of the children in the provider's care.
- (d) Family day care home and group family day care home operators shall obtain training pertaining to protection of the health and safety of children, as required by regulation, prior to the issuance of a license or registration by the office of children and family services.
- (e) Upon request by the office of children and family services, the child day care applicant or provider shall submit documentation demonstrating compliance with the training requirements of this section.
- 5.a. The site provider of a family day care home or group family day care home shall provide that at least one employee who holds a valid certification in a course of study in first aid knowledge and skills and cardiopulmonary resuscitation, with an emphasis on providing that aid to children, as approved by the commissioner of the office of children and family services, be on premises during the operating hours of such family day care home or group family day care home.
- b. The site supervisor of a school-age child care program shall provide that at least one employee who holds a valid certification in a course of study in first aid knowledge and skills and cardiopulmonary resuscitation, with an emphasis on providing that aid to children, as approved by the commissioner of the office of children and family services, be on premises during the operating hours of such school-age child care program.
- c. The director of a child day care center shall provide that at least one employee who holds a valid certification in a course of study in first aid knowledge and skills and cardiopulmonary resuscitation, with an emphasis on providing that aid to children, as approved by the commissioner of the office of children and family services, be on premises during the operating hours of such child day care center.

## Dear Jodi

Dear Jodi,

I'm a little confused about food allergy and intolerance. Can you explain what the difference is? I feel some of my parents are just as confused because I will see a child has an allergy on the day care registration written by the parent but not on the medical statement.

Dear Confused,

A food allergy is sometimes confused with food intolerance. Food allergies involve your immune system and can be life-threatening. An intolerance is when your body has trouble digesting a food. It can make you feel bad, usually with an upset stomach, but it is not life-threatening. The most common intolerance is to lactose—which is a natural sugar found in milk. The Anaphylaxis training on the ECETP web site also explains this. Just to be on the safe side, if you notice a difference from a document a parent gives you and the Medical, please have that conversation with the parent and if need be the doctor, document the conversation you have. If the child does have an allergy make sure the appropriate documents are completed by you, the parent, and the doctor. ~Jodi

# From the Desk of the Registrar

Hello everyone,

I would like to speak to you about childhood food allergies. Did you know 1 in every 13 children have a food allergy and up to 25% of children with food allergies will have their first reaction in the child care setting? Well neither did I, until I met Mrs. Dina Silvera, Elijah Silvera's mom. For those of you who do not know him he passed away in 2017, 3 years old from a severe yet well know dairy allergy. Eli was in daycare when someone gave him a grilled cheese. His epi pen was onsite! Staff did not recognize the signs and forgot about his alleray! His death was 100% preventable as is all 150 children per year who die from food allergies! Epi pens will not hurt a child. Do the training, get your non-specific pen free from OCFS. Make that difference in a child's life, the people who love them and your own.

Submit your timesheets online with the Child Care Time & Attendance (CCTA) System!

We encourage all providers to submit timesheets through the web-based system, CCTA.

There are several *benefits to using CCTA* web-based provider portal such as:

- ⇒ Eliminate the cost of shipping, mailing and purchasing paper products and postal supplies.
- ⇒ Eliminate time delay of using the postal service.
- $\Rightarrow$  TRACK PAYMENTS ON A DAILY BASIS.

It is recommended to use Internet Explorer on desktops or laptops. Most iPads and other hand held tablets are not supported by this system

\*\*REMINDER – ALL timesheets have a 60 expiration date from the last date of service. ANY TIMESHEETS that are RECEIVED AFTER the 60 expiration date (electronically or paper) will be RETURNED to provider as NOT PAYABLE\*\*

#### **Become a Legally Exempt Provider!**

Are you a parent struggling to find childcare? Do you know someone who has been struggling to find childcare? A family member or friend who is 18+ years old, can watch up to 8 children who are all related, and up to 2 children who are not related!

#### **Tips to Enrollment:**

- -MUST have a family with an approved child care assistance case
- -MUST complete pre-service training (Non-Relative only)
- -MUST submit a complete enrollment packet
- -All boxes/section must be checked/filled out, even if it is N/A
- -Non-Relative providers MUST complete a comprehensive background check
- **-Relative** providers **ONLY** include: Grandparent/Great-grandparent, Sibling who is living in a separate residence, Aunt or Uncle
- -To be classified as "In-Home", care MUST be done in the child's home, not the provider's
- -Enrollment process may take 40 days+

# **Business Support & Staff Retention**



The word spreads fast in a small community and you must be ready to market your childcare business at a moment's notice. If you're hoping to enroll more children, look at your environment. Is it clean, child-focused, safe, friendly, and warm? Here are a few things to consider:

- \* Did I return the inquiring parent's phone call promptly and communicate in a professional and friendly manner?
- \* Do I encourage inquiring parents to come and visit my program and when they do, am I proud of what I have to offer?
- \* Is the play area bright, child-focused, fun, and inviting?
- \* Does my childcare program have a pleasant odor?
- \* Is my childcare free from clutter, safe, and clean?
- \* Are there plenty of clean, age-appropriate toys?
- \* Is there an outdoor play space that is fun and safe, and do we use it regularly?
- \* Is the daily schedule posted and does it include a variety of activities that will encourage learning in all developmental areas?
- \* Are the staff friendly, warm, and welcoming?
- \* Is there a policy handbook, and do the policies make sense?

Word of mouth is typically the strongest marketing tool in our small community. If your parents are pleased with the care that you give to their children, they will tell others. Really listen to the parents in your program. Giving out a survey regularly helps you to give the very best care that accommodates the parents' needs. How do you communicate with your parents throughout the day? Do they know what their children are doing? Do you give out a daily handout about their child's day or do you use a childcare software platform that communicates with pictures, activity, and individual care details? Parents want to feel informed. They want to leave their children in safe and competent hands. Knowing that their children are having fun, learning through age-appropriate activities, and are in an environment that encourages self-confidence and feelings of security, leads to positive conversations in the community.
